If you choose the in-person option when requesting Power of Attorney, Advance Healthcare Directive, Probate or Miscellaneous Wills and Estate Services, you'll be prompted to search for an attorney in your area if you're in the U.S.

You can select an attorney through a drop-down listing of all in-network attorneys in your area and make an in-person or phone appointment.

3. Fee reimbursement

- 2. To submit a claim, call our Customer Service team using the number outlined above.

- 3. After the claims process is started and you've received a case number, you'll receive a fee reimbursement packet to fill out.
- 4. Follow the instructions on the packet. This will be used to gather the necessary information to generate a payment to you.
